Ecostal Group acquires Yomatec to accelerate expansion in France

Ecostal Group and the historical shareholders of Yomatec announce that they have reached an agreement for Ecostal Group to acquire 100% of Yomatec, a major player in the B2B distribution of equipment for photovoltaic installations in France.

The acquisition of Yomatec, established in Île-de-France, marks an important new stage in Ecostal Group's European expansion strategy. Already active in France since November 2022 through its subsidiary Ecostal, based in Béziers, Ecostal Group intends to use this acquisition to expand its presence in the French market. By setting up a platform in the Paris region Ecostal can provide maximum value to professionals in the photovoltaic energy sector.

"The complementary nature of Ecostal Group and Yomatec makes perfect sense," says Michel Ayache, CEO of Yomatec. "It was important for me to combine Yomatec's destiny with that of one of the leaders in the European market, and thus achieve critical mass in a market that is set to consolidate rapidly over the next few years. By joining forces, we are also giving French installers access to an even more comprehensive range of products. This opens up new prospects for our customers, our suppliers and users of photovoltaic panels in general. I look forward to embarking on this new adventure with the Ecostal Group team."

Christophe Piron, CEO of Ecostal Group adds: "Welcoming Yomatec to our group is a real opportunity and will help us to serve all installers in France even more effectively. Our product ranges are complementary, and Yomatec's presence in the Paris region will enable us to be even closer to our customers. Our DNAs are similar. We share the same desire to support our customers at every stage of their work."

Stéphane Dauvister, Chairman of the Board of Directors of Ecostal Group, is also delighted with this merger: "We are delighted that Michel is joining our group. The acquisition of Yomatec is a further step in our expansion strategy to become a European leader in the distribution of photovoltaic equipment."

Michel Ayache is appointed Managing Director and becomes a member of the Ecostal Group Executive Committee.
